# Financial Aid

## California State University Financial Aid Update

California State Universities have issued financial aid offers to newly admitted students starting the week of April 1 to students that have a processed Free Application for Federal Student Aid (FAFSA) or a California Dream Act Application (CADAA).

In some cases, students have had trouble filing the FAFSA, including students from mixed-status families. CSU Campuses have received FAFSAs from mixed-status students, as well as CADAAs for first year, first time applicants. The CSU will use either form to award state and CSU grant aid to mixed status students but will need a FAFSA to offer federal aid.

If you have students who have yet to receive their CSU financial aid offer and are trying to meet a May 1 acceptance deadline at another college or university, we recommend asking the other college for extra time to decide. As a reminder, the CSU has extended its [statement of intent to register \(SIR\)](#) deadline to no earlier than May 15, 2024, with many campuses extended to June 1.

## Students with Contributors without a Social Security Number

On April 30, 2024, the U.S. Department of Education announced changes to allow applicants and contributors without a Social Security Number (SSN) to immediately access the online 2024-25 FAFSA form after creating a StudentAid.gov account. These changes should significantly streamline the application process for prospective college students from mixed-status households. Mixed-status families include a student who is a U.S. citizen with one or more parents without a Social Security Number (SSN).

The Department is temporarily allowing individuals without an SSN to enter and complete the 2024-25 FAFSA. Contributors without an SSN must continue to manually enter their tax information. [Read the full announcement.](#)

Prospective college students from mixed-status households still unable to complete the Free Application for Student Aid (FAFSA), can complete a California Dream Act Application (CADAA) as a short-term measure until they are able to access and complete a FAFSA to receive the federal financial aid available to them. Students are encouraged to attempt to complete FAFSA first, to ensure that federal aid can be received. [Access additional instructions for mixed-status families completing the FAFSA.](#)

## Free Application for Federal Student Aid and California Dream Act Application

The state deadline to file the Free Application for Federal Student Aid (FAFSA) form and California Dream Act Application (CADAA) is **May 2, 2024**. The CSU encourages students to complete and submit their application as soon as possible.

### **CalKids - Free Money for College**
