Subject: **Priority Housing for Former Foster Youth**

Assembly Bill 1393 approved by the Governor on October 11, 2009 and filed with the Secretary of State on October 11, 2009, added Section 90001.5 to the Education Code. This section requires the California State University to provide housing priority to current and former foster youth on campuses that maintain student housing. This section also requires CSU campuses that have student housing open during school breaks or on a year-round basis to give housing priority to current and former foster youth.

On March 16, 2010, the California State University Board of Trustees took action to approve the Title 5 Revision that amended section 42002 on the California Code of Regulation. A copy of Title 5 California Code of Regulations that amended section 42002 is attached to this coded memorandum for your reference.

ARTICLE 5. HOUSING**

This database is current through 5/7/10 Register 2010, No. 19
§ 42002. Assignment of Priority.

Students of a campus shall have first priority to use student housing facilities of that campus, with the exception of space granted to special programs by the campus president as outlined in Section 42003.

Each campus that maintains student housing shall give housing priority to current or former foster youth. For campuses that have student housing open for occupation during school breaks or on a year-round basis, the first priority shall be in housing that is open for uninterrupted year-round occupation.
