	<p>plane crash than an automobile crash, even though statistically, it is 67 times riskier to travel the same distance by car than by plane. REAL risk and PERCEIVED risk can often be very different. As risk and safety professionals, one of our key responsibilities is helping people to assess risks as accurately as possible, and narrowing the gap between the perception of risk and the actual risk. Because we make our decisions and take actions based on how we perceive risks, it is important that the perception of risk matches the reality of risk as closely as possible.
