## SUBJECT: 2024-2025 through 2028-2029 Five-Year Capital Improvement Plan

This memorandum is to initiate the capital planning process for the Five-Year Plan covering the 2024-2025 through 2028-2029 budget years in support of the 2024-2025 budget request. The memorandum also provides the submittal schedule (Attachment 1) and a list of necessary documents (Attachment 2) to ensure that campus input can be timely incorporated into the final CSU Five-Year Plan.

The Five-Year Plan, required by Education Code 67501, represents the campuses' forward thinking long-term development program. The campuses' capital priorities are displayed in the order in which they intend to initiate projects to meet the campus needs and align with the Board of Trustees priorities.

Capital Planning, Design and Construction (CPDC) is requesting project submittals in two phases. The first phase will include debt-financed academic facility and self-support projects for large projects over approximately \$10 million. The second phase submittals will be smaller capital and infrastructure improvement projects as well as deferred maintenance projects.

The submittal dates are different from previous years. The purpose of the change is to provide more time for legislative advocacy activities between plan approval by the Board of Trustees, expected in September 2023, and the Governor's Budget Proposal in January 2024.

Although the systemwide need to address critical infrastructure and modernization continues to grow, funding levels for the 2024-2025 capital program is uncertain. This call for campus projects aims to ensure we adequately document our need, support advocacy efforts, and best position the CSU for available funds.

## Phase One Submittals – March 1, 2023

Each campus may submit one major debt-financed academic facility or self-support project for the 2024-2025 budget year. They may also submit up to three major debt-financed academic facility or self-support projects for years 2025-2026 through 2028-2029. These projects should

align with the Board of Trustees established priorities, addressing critical infrastructure deficiencies, providing for modernization and renovation of existing buildings, and finally providing for limited growth if necessary. Over the next several weeks, CPDC university planners will work closely with campus staff and provide training to help develop the documents that are due on March 1, 2023.

## Review Process March 1 – March 30, 2023

After the initial submittal, CPDC staff will continue to work with campus planning staff to refine project documents in preparation for the submittal to the Board of Trustees, the Department of Finance (DOF), and the Legislature. During this period campuses should begin to prepare their list of smaller capital and infrastructure improvement projects as well as their list of deferred maintenance projects.

During the spring 2023 budget hearings, better information should be available to estimate the level of funds for deferred maintenance or capital improvements for the system to enable an estimated allocation amount for each campus. This information will help the campus confirm the priority deferred maintenance and infrastructure improvement projects to be funded in 2023. This will allow campuses to revise the 2024-2025 list to reflect projects funded in 2023-2024 as part of the Phase Two Submittals process described below.

## Phase Two Submittals – May 5, 2023

Phase Two submittals will include all campus projects to be included in the 2024-2025 through 2028-2029 Five-Year Plan. Submittal requirements are outlined in Attachment 2 and are necessary in order to support the major academic and self-support projects as well as the smaller capital and infrastructure improvement and deferred maintenance projects. Projects included in the May 5 submittal will be included in the CSU Preliminary Capital Outlay Plan in the item presented to the Board of Trustees at their July 2023 meeting and provided to the DOF on September 1, 2023. The Final Capital Outlay Plan will be presented to the Board of Trustees at their Submitted to DOF by December 1, 2023.

## **Project Priority Setting**

The Board of Trustees has established Categories and Criteria for priority setting of the Five-Year Plan that should be considered while developing the campus plan.

The categories remain as follows:

- I. Existing Facilities/Infrastructure A. Critical Infrastructure Deficiencies B. Modernization/Renovation
- II. Growth/New Facilities



## **Feasibility Studies**

Campuses are required to provide funding for the completion of feasibility studies for their complex and likely debt-financed projects. Any 2024-2025 action-year capital requests shall include comprehensive feasibility study documentation to help ensure that campus programming is complete, and the budget request accurately reflects the proposed scope of the work. Renovation projects should address the facility's programmatic needs, seismic safety, facility renewal backlog, accessibility, hazardous materials, fire safety, etc., and how the renovation will be accomplished (vacate building, lease space and/or phased construction). The completion of the feasibility study also aims to ensure the project proposed costs are reasonable in light of the Board of Trustees continued concern on the cost of construction.

# Enrollment Projections and Campus Physical Capacity

Enrollment and space capacity companion reports to the 2023-2024 Five-Year Plan are key tools used for project planning and prioritization. Those reports will be available soon on the CPDC website. Any campus proposing projects to increase seat capacity for lecture, labs and/or faculty offices need to demonstrate the specific deficiency that the request is aiming to overcome and are to submit projected enrollment increases by discipline which will be used to update the below reports for the 2024-2025 program.

Key inputs for the development of the space capacity companion reports come from the Academic Planning Database (APDB). In recent years there have been some significant reporting and data quality issues with the APDB. This affects the analysis of campus capacity and utilization resulting in faulty reports and possibly an inaccurate representation of campus space needs. These reports allow us to communicate our facilities needs to the Board of Trustees and the Legislature. Over the next few months we will be working with Academic and Student Affairs and campuses to improve this data and the resulting reports. It may be that the transition to remote instruction due to COVID and continued use of hybrid instruction to serve student demand is part of the reporting challenge.
